## Purpose:

The purpose of this report is to provide West Elgin Council with an update on operations carried out within the Municipality during the month of August.

# **Background:**

#### **Public Works**

- Basin cleaning and inspection was completed in Rodney, West Lorne and all outlying areas.
- Sidewalk inspections were completed and identified trip hazards dealt with.
- Summer maintenance activities were completed at the municipal gravel pits.
- Recycling and landfill operations ongoing.
- Tree service and removals done at various locations as required.
- Gravel washouts on Grey Line hills repaired.
- Replacement of missing signs along county roads.
- Ditching work performed on Blacks Road in advance of surface treatment
- Wash out on Fleming Line repaired
- Elm street drain/shoulder rehab west of Ridge Street finished.
- Completion of stop block painting on various municipal roads.
- Public Works staff handled road closure for 'Toonie' Tuesday.

#### Parks and Recreation

- Daily cleaning of Marina and Miller Park washrooms.
- Daily watering of flowers.
- Regular grass cutting at all locations.
- Weekly line painting at soccer fields in Miller Park.
- Full pool schedule running until the end of August.
- · Magic show rental at the Arena.
- West Lorne 'Soccer Cup' day was held in Miller Park.
- West Lorne Community Centre (Arena) renamed to the Bo Horvat Community Centre.
- Preparations started at the arena for the ice season.

# Utilities

- Staff fixed a water leak at PGTP
- A 6" water service was installed for hydrants at the new storage locker facility on Pioneer Line
- Staff worked to installed radio transmitters on water routes 3 & 4
- Utility staff assisted with annual inspection of emergency equipment and fire extinguishers at all municipal buildings.
- Locates, reads, all other regular duties as assigned.
