AUGUST EMCPA COMPLIANCE TOPIC - CEMC/ALTERNATE CONTACT APP UPDATE REMINDER

Don't forget! Last year, Emergency Management Ontario (EMO) launched the new Provincial Contact Management program. The Community Contact app improves how communities update contact information for the primary Community Emergency Management Coordinator (CEMC), Alternate CEMC(s), Emergency Information Officer (EIO), other community 24/7 emergency contacts, and the elected leadership contact. This Community Contact app has replaced both the "Form 4-1" process and the "CEMC contact information" section within the EMO compliance program.

The Community Contact App is specifically designed for communities to create and or update existing emergency contact information for their community. One or more users can be designated within a community to manage this information.

We ask that communities visit the site <u>Login | Emergency Management Ontario</u> and access the My Community Contacts App to review and if need, update their contact information. Communities are now empowered and encouraged to create and update their contact information as required throughout the year. Respecting that you will not be doing this frequently, assistance with this process is available from your local Field Officer
